



(1) For the functional group workshop staff including engineering workshop staff, the minimum prescribed qualification as per council letter F.No.19(10)/2004-estt.IV dated 24<sup>th</sup> Feb,2006 for category-II (Technical Assistant/T-3) are bachelor's degree/three years diploma in the relevant field or equivalent qualification from a recognized University.

No specific guidelines regarding equivalent qualification has been issued by ICAR, therefore, it is matter to be decided by the screening committee whether an applicant has equivalent qualification for the advertised post.

(2) As per qualification prescribed in the advertisement is bachelor's degree in Agriculture Engineering or three years diploma in the relevant field or equivalent qualification from a recognized University. Therefore, for the post of farm engineer other than above qualification are not admissible.

(3) Council vide its letter No.TS19(05)/2017-Estt.IV dated 20.04.2020 has abolished vacancies of T-1(except for those falling under fabrication staff & Fishing vessel crew). However, as desired, the vacant position of T-3 are as under:


