Accordingly, sealed quotations are invited for the disposal of the said vehicles on the terms and conditions mentioned below, Persons/firms, interested in purchasing the above mentioned vehicles, may submit their highest quotations in the enclosed Performa in a sealed cover addressed to the undersigned latest by 03.00 PM on or before\_01.02.2024 in the Tender Box kept at Admin office of Arid Regional Campus, (ICAR-CSWRI) Bikaner (Raj)-334006. The quotations received in time will be opened at 4.00 pm on the same day i.e. on 01.02.2024, in the ARC, ICAR-CSWRI, Bikaner office, The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time opening of Quotations, the cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".
- 3. The vehicles will be available for inspection between 03:00 PM. To 4:00 PM on  $30^{th}$  to  $31^{st}$  Jan, 2024.
- 4. The Auction of said vehicles will be governed by the following conditions:-
  - I. The bidders are require to deposit Earnest Money of Rs. 15,000/-(Rupees fifteen thousand only) for Ambassador Car and & Rs. 5,000/- (Rupees five thousand only) for Tractor.
  - II. The interested Persons / Firms are required to deposit (in original) Earnest Money in the form of Demand Draft in favour of **CSWRI UNIT ARC Bikaner** (payment by cheque or cash shall not be accepted).
  - III. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.
  - IV.
