Subject: **Representations from Government servant on service matters - reiteration of instructions - regarding.**



This practice tantamount to bringing outside influence and is considered as violation of Rule 20 of CCS (Conduct) Rules, 1964. This has been viewed seriously by the competent authority. All the ICAR officials are advised to adhere to the aforesaid instructions and any violations of these instructions/guidelines may attract initiation of disciplinary proceedings as per rules and this would be taken on personal record of the concerned personnel.

This issues with the approval of the competent authority.





