- 3. The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his tenders, he will not resile from his offer or modify the terms and conditions thereof. If the tenderer fail to observe and comply with the foregoing stipulation the aforesaid amount of EMD will be forfeited by the Institute. NOW IT IS HEREBY AGREED be and between the parties hereto as follows;

- 1. This agreement shall come into force w.e.f. ----- (date) and will remain in force for a period for one year but can be terminated by Central Sheep and Wool Research Institute by giving one calendar month's notice in writing of its intentions to terminate the Agreement. The Agreement can be renewed, on mutually agreed terms.
