- NOTE :** 1. The posts mentioned at S. No. 1, are in addition to the posts already advertised vide Advertisements No. CSWRI/03/2013 & CSWRI/04/2014, CSWRI/13/2014 & CSWRI(NTRS)/14/2014. The candidates who had already applied earlier, in response to the above advertisements for the post mentioned at S. No. 1, need not to apply again.
2. The vacancy position is tentative and liable to change (increase or decrease).

General Instructions for Candidates:-

- The minimum and maximum age limit is 18-25 Years for skilled Support Staff and 18-30 years for Technician/T-1 & Technical Assistant/T-3.
 - Relaxation in upper age limit will be five years for SC/ST, three years for OBC, 10 years for Persons with Disabilities candidates and any other category will be allowed as per the extant rules of the Govt. of India/ICAR issued from time to time.
 - Relaxation in upper age limit for Ex-Servicemen will be allowed as per the existing instructions of the Govt. of India/ICAR issued from time to time.
 - For regularization of casual labourers with temporary status age limit shall be as per DOPTs OM No. 5106/2/90-Estt.(C) dated 10.09.1993, if applied concerned for Skilled Support Staff.
- No age limit for I.C.A.R. employees to Technical posts. For Research Associates/Senior Research Fellows who have been engaged on contractual basis in different ICAR Institutes as on date [cut off date for receipt of duly filled application] are eligible for relaxation in the upper age limit to the extent of their spell, during which they were actually engaged as**

RAs/SRFs in different projects of ICAR Institutes [maximum of 16 years 03 months]. They should have been engaged continuously in different projects of ICAR Institutes without inordinate spell of breaks. An employment certificate indicating the names of the projects and the exact period he/she worked in each project, may be obtained from the Competent Authority and enclosed along with the application. The applications without Employment Certificate and authentic proof will not be entertained. The age relaxation is applicable for the post of T-3/Technical Assistant under Direct Recruitment for RAs/SRFs only. This dispensation is only for relaxing the maximum age limit and does not imply any other relaxation whatsoever regarding essential qualifications and experience etc.

3. Last date for receipt of applications is **21.01.2016 (for applicant posted in Andaman and Nicobar Islands, Lakshdweep, Minicoy and Amindeivi Islands, States/Union Territories in the North-Eastern Region, Ladakh Division of J&K State, Sikkim, Pangi is 05.02.2016)**. Applications received after last date will not be entertained. **The Director, CSWRI, Avikanagar reserves the right to cancel the recruitment process at any stage due to one reason or the other.**
4. Mere possession of higher qualification does not entail any right to any candidate for call of examination. Only short listed candidates will be called for examination.
5. Crucial date for determining the age limit of candidates will be the closing date of receipt of applications.
6. Community Certificate for SC/ST/OBC may be obtained from the competent authorities in the latest standard format as prescribed by Govt. of India from time to time.
7. Candidates who claim to be Persons with Disability will be required to submit Medical Certificates as per disability in the new prescribed applicable format issued by the Competent Medical Authorities for the Purpose of employment.
8. Documents in support of claim of Ex-Servicemen category should be enclosed alongwith the application form.
9. The post is non-government under the Indian Council of Agricultural Research which will be governed by the New Pension Scheme introduced by the Govt. of India with effect from 01.01.2004 mutatis-mutandis and as amended from time to time.
10. The posts are purely temporary but likely to continue.
11. For the posts mentioned at Sl.No. 2, 3 & 4, the Selected candidates will have to undergo one year on-the-job training, which will be provided by the Institute. The selected candidates will be called as Technical Trainee during the training period. After successful completion of the one year training, a certificate to this effect will be provided by the Director of the Institute and regular appointment will be done.
12. The place of posting **of selected candidate will be as per their merit** at CSWRI, Avikanagar or its sub-stations i.e. SRRC, Mannavanur, Kodaikanal – 624 003 (T.N.), NTRS, Garsa – 175 141, Kullu (H.P.) and ARC, Bikaner – 334 006 (Rajasthan). However, appointees will be liable to serve in any Institute of ICAR anywhere in India.
13. The candidates who are in service in the Central/State Govt./Undertaking/Autonomous bodies etc. should apply through ‘proper channel’.
14. The candidate should give declaration in the application form at serial number 10 whether he/she is related/not related to any employee of the CSWRI/ICAR and if so, he/she has to provide the details.
15. No TA/DA is admissible for attending the examination.
16. Applications received after the due date for any reason including postal delays will not be entertained.

Candidates belonging to SC/ST/PwD and Women candidates of all categories are exempted from payment of application fee. Any candidate who may be applying for more than one post should submit separate application for each post alongwith the prescribed application fee. Attested copies of Caste Certificate, Marks-sheets, matriculation certificate for age proof and Experience Certificate etc. should be attached along with each application. **Candidates before applying for the post(s) must satisfy that they are eligible to apply and fulfill the criteria/essential qualification/ age etc. prescribed for the post(s).**
