Ours is an Institution under the **Indian Council of Agriculture Research (ICAR)**. We are having import code as well as duty exemption certificate from the competent authorities.

It is proposed to appoint Custom Clearance Agent for clearance of our Import consignments at IGI Airport, New Delhi on the following terms and conditions:-

1. The contract will be for a period of one year from the date of award, which can be extended further.
2. You must process valid Licence from the Govt. Copy of the Licence must be enclosed with the offer.
3. Complete documents will be provided for clearance of consignment from Customs. After clearance, the consignment will be collected by us in due course of time.
4. All charges such as IAAI charges, customs duty (if any), and other statutory charges will be paid at actual against proper receipt/voucher only after clearance of consignment.
5. All charges should be intimated in clear terms as per the enclosed Annexure. No claim for any other charges not mentioned in the Annexure will be entertained later on. The consignment is proposed to be imported/booked through National carriers i.e. Air India, Indian Air lines etc.
