**OFFICE ORDER**

Consequent upon recommendations of the Departmental Screening Committee, the Competent Authority of the ICAR-CSWRI, Avikanagar is pleased to grant financial up-gradation to the next higher Grade Pay / Level in the Pay Matrix as mentioned against each to the following Skilled Support Staff of the Institute with effect from the date indicated against his name under the Modified Assured Career Progression Scheme in terms of O.M. No. 35034/3/2008-Estt.(D) dated 19.05.2009 received from the Ministry of Personnel, Public Grievances & Pensions (Department of Personnel and Training) endorsed by the I.C.A.R. vide letter No. 33(3)/2009-Estt.I. Dated the 2<sup>nd</sup> March, 2010 & subsequent O.M. No. 35034/3/2015-Estt.(D) dated 27.09.2016 and clarification received from time to time. This financial up-gradation shall be purely personal to the employee and shall have no relevance to his/her seniority. The pay shall be fixed under the provisions of FR 22 (I) a (I) and other instructions of ICAR/Govt. of India issued from time to time:-

*Note:- Since, his 3<sup>rd</sup> MACP was due w.e.f. 13.06.2020 but due to not meet out the benchmark APARs grading as 'Very Good' from 25.07.2016 for granting MACP, the committee had not recommended for granting 3<sup>rd</sup> MACP in the meetings held on 31.10.2020 & 14.03.2022. Further, he was on EOL without MC from 10.04.2011 to 13.04.2011 & 30.04.2011. Now, therefore, new Due date is w.e.f. 18.06.2022 in the 7<sup>th</sup> CPC's Pay Level -4 (25500-81100).*

His/her pay will be fixed under normal rules. Hence, he has to furnish his option for fixation of pay in the next higher level in the 7<sup>th</sup> CPC pay matrix within a period of one month from the date of issue of the order. Failing which, pay will be fixed as per rules.
