### Office Memorandum

**Subject: Revision of allowances of scientists of ICAR as per recommendations of 7<sup>th</sup> CPC-reg.**

In continuation of Council's communication No. 1(4)/2017-Per.IV dated 27.03.2018 & 19.06.2018 and No. 1(4)/2018-Per.IV dated 05.12.2018, the Competent Authority of Indian Council of Agricultural Research (ICAR) has decided to revise the allowances of Scientists of ICAR w.e.f. 01.07.2017 in light of revision of allowances of teachers in Universities and colleges as per recommendations of 7<sup>th</sup> CPC notified by M/o HRD vide letter No.1-4/2017-U.II dated 28.01.2019 and 01.02.2019.

2. It has been decided that the rate of allowances admissible during the 6<sup>th</sup> CPC shall be revised in accordance with the provisions of the Department of Expenditure's OM No. 1/1/2016-E-III(A) dated 26.07.2017, read with Department of Expenditure's Resolution dated 06.07.2017 and Government orders issued in the matter, for teachers and equivalent academic staff in Central Universities and colleges thereunder and centrally funded Deemed to be Universities.
3. It is also informed that the rate of Special Allowance of Rs 5000/- for the following posts has been revised by a factor of 2.25 to Rs. 11,250/- :
  - i. Director, IARI, New Delhi
  - ii. Director, IVRI, Izatnagar
  - iii. Director, NDRI, Karnal
  - iv. Director, CIFE, Mumbai
  - v. Director, IIAB, Ranchi
  - vi. Director, NIBSM, Raipur
