

Sub: Exercise of option to draw Transport Allowance to Official holding post to which staff car attached: Reg.

Ref: F. No. FIN/24/1/2008-CDN (A&A) dated the 10th July, 2009

It had been clarified vide order under reference that in case where official car is attached to the post such as Director of ICAR Institutes, Joint Director of Deemed University and other similar posts, the incumbent would not be entitled to exercise option to draw Transport Allowance by claiming that he would not use the official car.

- Reference has been received whether these instructions are applicable to Officers who are holding the charge of Director/Jt. Director etc. in Acting/Officiating basis in absence of regular incumbent. It is now clarified that the Officers holding the charge of Acting/Officiating Directors of ICAR Institute, Joint Directors of Deemed University etc., in addition to his allotted duties, will also not be entitled to draw Transport Allowance (and dearness allowance thereon) by claiming that he would not use the official car, during the period he holds the charge in Acting/Officiating capacity.
- These issues with the approval of DG, ICAR.
