

As per clause 4(a)(iii) of Council's OM No.38(2)/2011-Per.IV(Pt.) dated 01.10.2020, the ARS Scientists who have been transferred on working spouse ground, shall not be considered again for transfer on working spouse ground during his/ her entire service period.

As per clause 8(vi) of Council's OM No.38(2)/2011-Per.IV(Pt.) dated 01.10.2020, the ARS Scientists, once transferred to the place of his/ her first choice cannot apply for transfer for the next 10 years. In case of Scientists joining second or third choice, minimum retention period shall be applicable for applying for transfer again.

The Scientists who have been transferred from 'B' category stations, after completion of their tenure of 3 years at the Station, will be entitled for TTA, joining time etc. as per clause 9 of Council's OM No.38(2)/2011-Per.IV(Pt.) dated 01.10.2020. In other cases, no TTA, joining time will be admissible.
